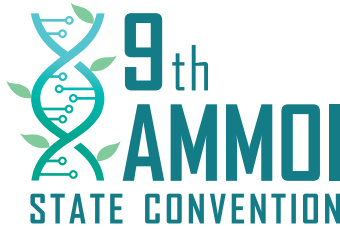

These achievements include formation of NMPB, Traditional Knowledge Digital Library, implementation of Good Manufacturing Practices, reduction of GST on Ayurvedic medicines, extension of the validity of SP6 and SP7 licenses etc. We are actively working towards formation of Indian Standards with BIS, creation of skilling courses in Ayurveda with HSSC sub council, exemption of ayurvedic medicines from denoting USP as per legal metrology rules, insurance coverage for Ayurvedic treatment, and supporting the capacity building of medicinal plant cultivators through the aid of NMPB.

We have actively addressed various issues such as export-related challenges, biodiversity act issues, adequate representation for ayurveda in Kerala Public Health bill, combating social media propaganda against Ayurveda (particularly on Wikipedia) and advocating for lowered minimum wages and ensuring that 20% of medicines under NAM and NHM are sourced from GMP certified private Ayurvedic manufacturing companies.

As a part of this convention and anniversary celebration, we have planned various exhibitions at the venue. The success of this event can be achieved only with the support and cooperation from every member of this organization. Together, we can make this event a visionary approach towards the promotion of Ayurveda.
